<b>LOCATION</b>	<b>KLIEVER ARMORY 10000 NE 33rd Avenue, PORTLAND OR 97211</b>
<b>CHECK-IN</b>	<b>Thursday, August 27th, 11:00 AM to 4:00 PM</b> DEALERS <u>MUST</u> CHECK IN WITH THE SHOW CHAIR BY 10:00 AM ON AUGUST 28TH OR FORFEIT SPACE UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH THE SHOW CHAIR.
<b>SET-UP</b>	<b>Thursday, August 27th, 11:00 AM to 4:00 PM</b> Coming from the south on 33rd Ave, take the southern entry and drive to the back (east side of building). Coming from the north on 33rd Ave, take the second entry and drive to the back (east side of building). Unload at the back and then park.
<b>DATES/TIMES</b>	<b>Friday August 28th General Admission 10 AM - 5 PM</b> <b>Saturday August 29th General Admission 10 AM - 4 PM</b>
<b>PACK-OUT</b>	<b>Saturday, August 29th 4 PM – 5:30 PM</b> Load out from the east side of the building.
<b>RENTAL</b>	<b>\$80.00 per 8' x 30" table. This includes a backup table.</b>
<b>PARKING</b>	<b>Southeast section of the parking lot.</b>
<b>SMOKING</b>	<b>Smoking is not allowed in Kliever Armory.</b>
<b>PETS</b>	<b>Pets are not allowed in the hall at any time.</b>

## ◆◆ 2026 ANTIQUE PAPER ROUND-UP GUIDELINES ◆◆

The following Guidelines define the agreement between you as the Member Dealer and the Webfooters Post Card Club.

1. **Membership:** All Dealers must be current members of the Webfooters Post Card Club - \$18 Individual Dues or \$20 for a Family. An application is available at: [www.thewebfooters.com](http://www.thewebfooters.com) or it can be sent to you upon request.
2. **Laws, Rules and Regulations:** All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety shall be strictly obeyed. The Member Dealer agrees to keep all merchandise, chairs and other equipment within the marked boundaries of the booth.
3. **Space Rental:** Each Agreement between Member Dealer and The Webfooters Post Card Club will designate a space area or booth in conformity with the floor plan. Due to last minute changes for building safety, fire codes, and show layout or for just reason, the Member Dealer may be relocated.
4. **Location:** Portland's Webfooters Post Card Club cannot guarantee your booth location, but if you have a special location request, please indicate it in the space provided on the contract and we will try to accommodate it.
5. **Member Dealer:** The Member Dealer agrees that the booth under contract will be open and adequately staffed during all public show hours.
6. **Content of Booth:** Acceptable merchandise: Post cards, photos, other antique or vintage papers (ephemera, maps, advertising, books and posters) and souvenirs. No displays to exceed five feet in height, except for dealer members who have wall spaces.
7. **Release and Hold Harmless:** This request to reserve vendor space constitutes an expressed contractual agreement between The Webfooters Post Card Club and it is understood and agreed that by signing this agreement, I fully and finally release and hold harmless The Webfooters Post Card Club, it's agents and members, and the landlord of the venue and it's agents and employees from any and all liability for all claims of every nature and kinds whatsoever, including death, personal injury, loss, theft, or damages to personal property. (Whether or not caused by The Webfooters Post Card Club's or Landlord's own Negligence or the negligence of their agents and employees.
8. **Insurance:** The Member Dealer is responsible for obtaining his or her own insurance coverage to insure against theft, fire, smoke, flood or any other loss or casualty. Each dealer member accepts the full liability for any injury or loss to themselves or helpers, family, or property while at the show.
9. **Payment and Cancellation Policy:** In the event of a need to cancel, a full refund will be made, provided that the cancellation is received two weeks prior to the show date. No refund will be made if the cancellation is received less than two weeks prior to the show date. Dealers who fail to arrive at the show location by 10:00 am August 28, 2025, will be subject to cancellation and forfeiture of table fees.
10. **Conduction of Business:** All business and displays must be within your designated space.

**Directions: From I-5: take exit 307 in North Portland, Oregon, for access to Marine Drive East. This exit connects to N Marine Drive, which runs along the dike toward the Portland Airport area. From both I-5 North and South, follow signs for Marine Drive East. Go east to 33rd and turn right. Go about ¼ mile and turn left into the southernmost parking lot.**

**From I-205: Exit 24 for US-30 Bypass/Killingsworth St and head west toward the river, then north on 33rd towards Marine Drive. Turn right into the southernmost parking lot entrance**
